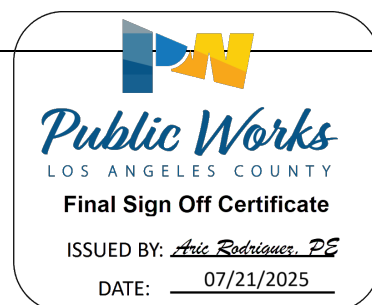

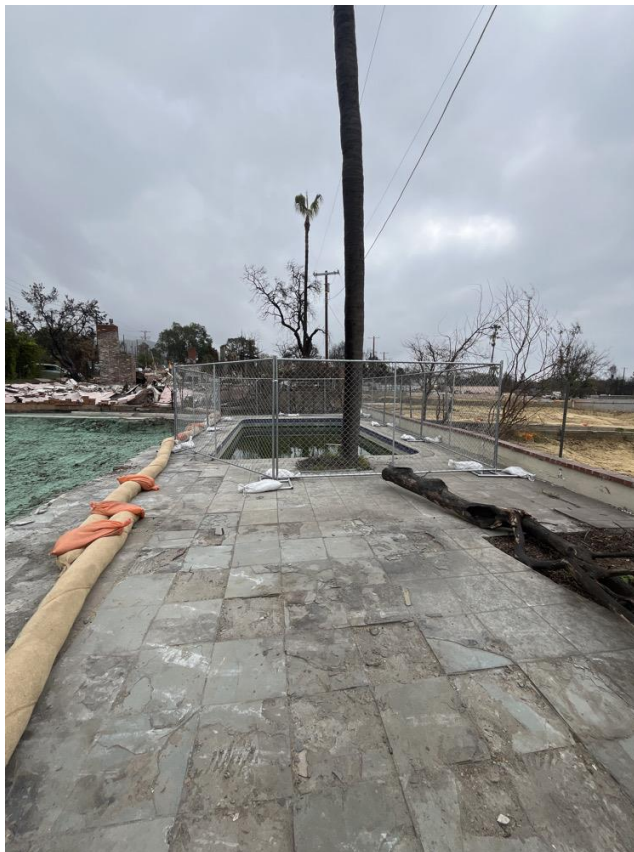


Photo Description: Pool fence

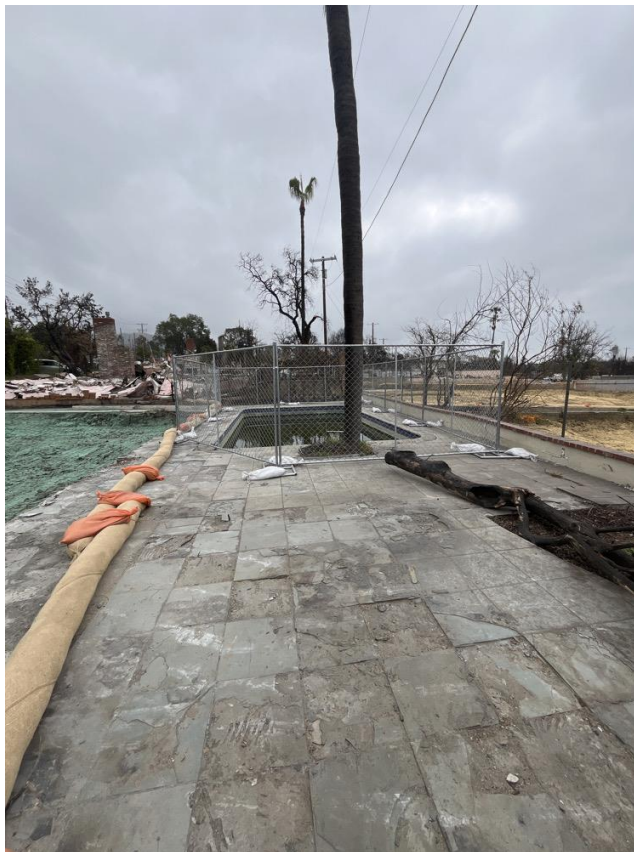


Photo Description: Safety fence
