* GFCI & Receptacle Corrections:

Upon evaluation, it was noted that customer had previously attempted to perform electrical repairs. illectric identified improper terminations and non-compliant devices during troubleshooting. Existing receptacles were reterminated as needed to ensure proper and safe connections.

illectric supplied and installed tamper-resistant GFCI receptacles where existing customer-provided devices were not code-compliant. Installed one (1) GFCI in garage to protect adjacent receptacle on common wall, one (1) GFCI in laundry room, and one (1) GFCI in bathroom location configured to protect both bathroom receptacles.

Additionally, illectric replaced customer-supplied tamper-resistant standard receptacles in island, hallway, and master bedroom locations.

All devices installed to meet current tamper-resistant and GFCI protection requirements where applicable. Customer-supplied materials are not warranted; illectric warranties workmanship for one (1) year.
