

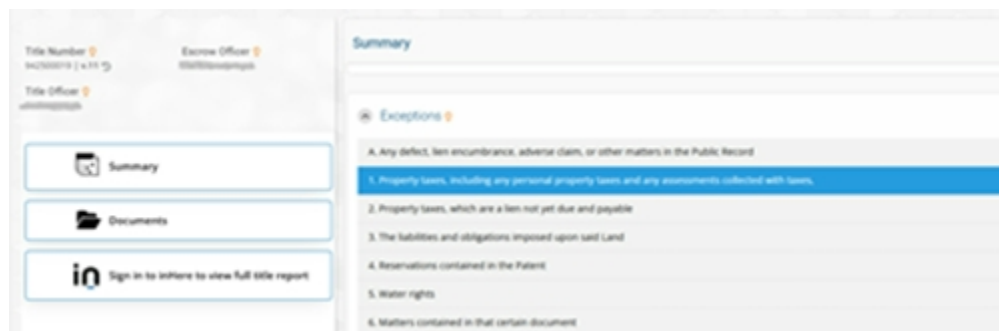

3. Any defect, lien, encumbrance, adverse claim, or other matter:

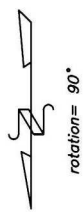

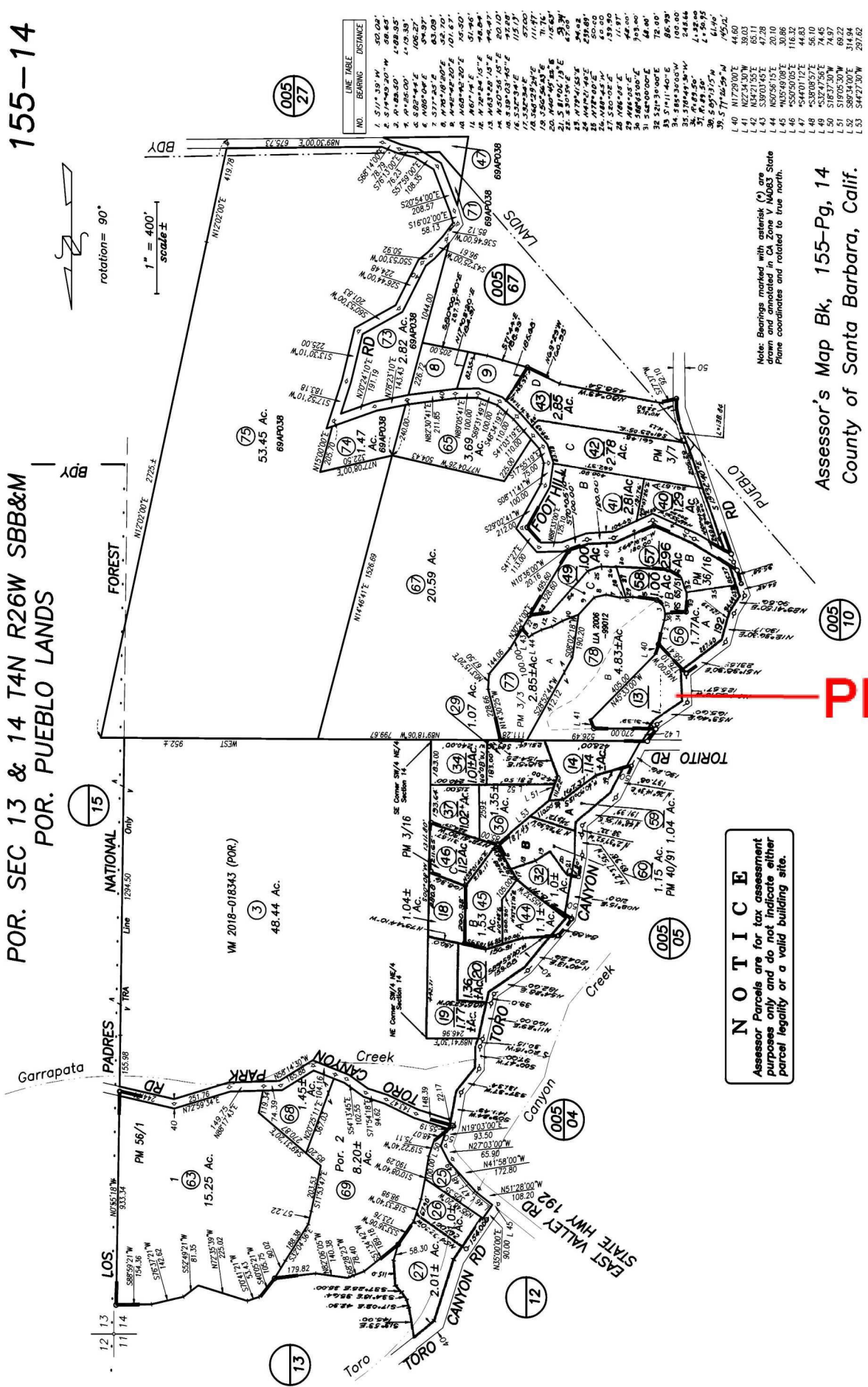
