**AMENDMENT TO NOTICE TO SELLERS AND PURCHASERS
OF REAL ESTATE SITUATED IN

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 134D §

Pursuant to V.T.C.A., Texas Water Code, Section 49.452 and 49.455, et. seq., as amended, the Board of Directors of the above-named municipal utility district (the "District") hereby makes this Amendment to Notice to Sellers and Purchasers of Real Estate situated within the boundaries of the District.

The only modifications and updates to the notice since the previous amendment are in regard to item numbers 5 and 9, which now should read as follows:

5. The aggregate initial principal amount of all bonds of the District payable in whole or in part from taxes (excluding refunding bonds and any bonds or portion of bonds payable solely from the revenues received or expected to be received pursuant to a contract with a governmental entity) that have been previously issued is \$87,335,000 for water, sewer, and drainage facilities, \$0 for road facilities, and \$0 for parks and recreational facilities.
9. The form of the Notice to Purchasers is as follows:

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property, described below, which you are about to purchase is located in Fort Bend County Municipal Utility District No. 134D (the "District") and may be subject to district taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.92 on each \$100 of assessed valuation.

The total amount of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters and excluding any bonds or any portions of bonds issued that are payable solely from revenue received under a contract, approved by the voters are:

- (i) \$206,000,000 for water, sewer, and drainage facilities;
- (ii) \$0 for road facilities; and
- (iii) \$0 for parks and recreation facilities.

The total aggregate initial principal amounts of all such bonds issued are:

- (i) \$87,335,000 for water, sewer, and drainage facilities;
- (ii) \$0 for road facilities; and
- (iii) \$0 for parks and recreational facilities.

The District is located partly in the extraterritorial jurisdiction of the City of Houston, located partly in the extraterritorial jurisdiction of the City of Richmond, and located partially outside the extraterritorial or corporate jurisdiction of any municipality. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a district that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Richmond. The agreement may address the timeframe, process, and procedures of the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of this District is to provide water, sewer, drainage, or flood control facilities. The cost of District facilities is not included in the purchase price of your property.

The legal description of the property that you are acquiring is as follows: See Exhibit "A" attached hereto.

PURCHASER IS ADVISED THAT THE INFORMATION SHOWN ON THIS FORM IS SUBJECT TO CHANGE BY THE DISTRICT AT ANY TIME. THE DISTRICT ANNUALLY ESTABLISHES TAX RATES. PURCHASER IS ADVISED TO CONTACT THE DISTRICT TO DETERMINE THE STATUS OF ANY CURRENT OR PROPOSED CHANGES TO THE INFORMATION SHOWN ON THIS FORM.
