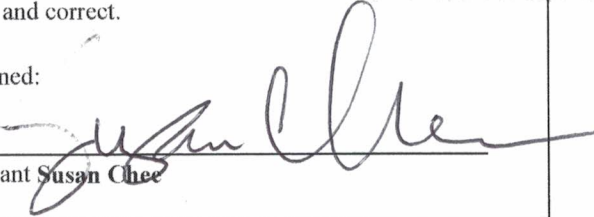
Before me, the undersigned notary for the State of Fort Bend personally appeared Affiant(s) who after by me being duly sworn, stated:

 - d. conveyances, replattings, easement grants and/or easement dedications (such as a utility line) by any party affecting the Property.

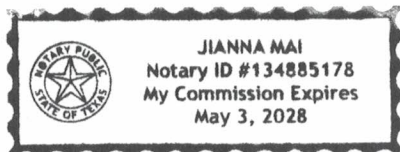
