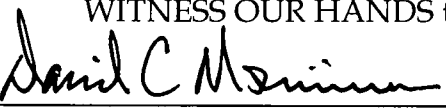

CODE §293.92. We do hereby certify as follows:

1. The aggregate initial principal amounts of all bonds issued for one or more of the specified facilities of the District and payable in whole or in part from property taxes is \$20,990,000 for water, sewer, and drainage purposes, \$13,490,000 for roads, and \$5,785,000 for parks and recreational facilities.

2. The form Notice to Purchasers required by §49.452, Texas Water Code, as amended, to be furnished by a seller to a purchaser of real property in the District is attached hereto as **Exhibit A** and incorporated herein for all purposes.

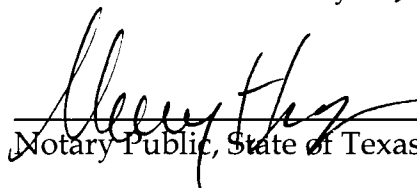

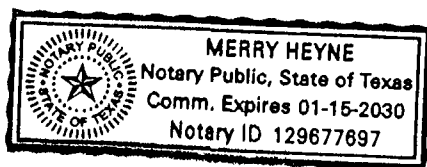

EXHIBIT A

NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Waller County Municipal Utility District No. 37 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The current rate of the District property tax is \$1.50 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding refunding bonds that are separately approved by the voters, approved by the voters are:

\$122,760,000 for water, sewer, and drainage facilities;

\$117,145,000 for road facilities; and

\$40,545,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

\$20,990,000 for water, sewer, and drainage facilities;

\$13,490,000 for road facilities; and

\$5,785,000 for parks and recreational facilities

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a District that is annexed by the municipality is dissolved.

The purpose of the District is to provide water, sewer, drainage, flood control, road, parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.
