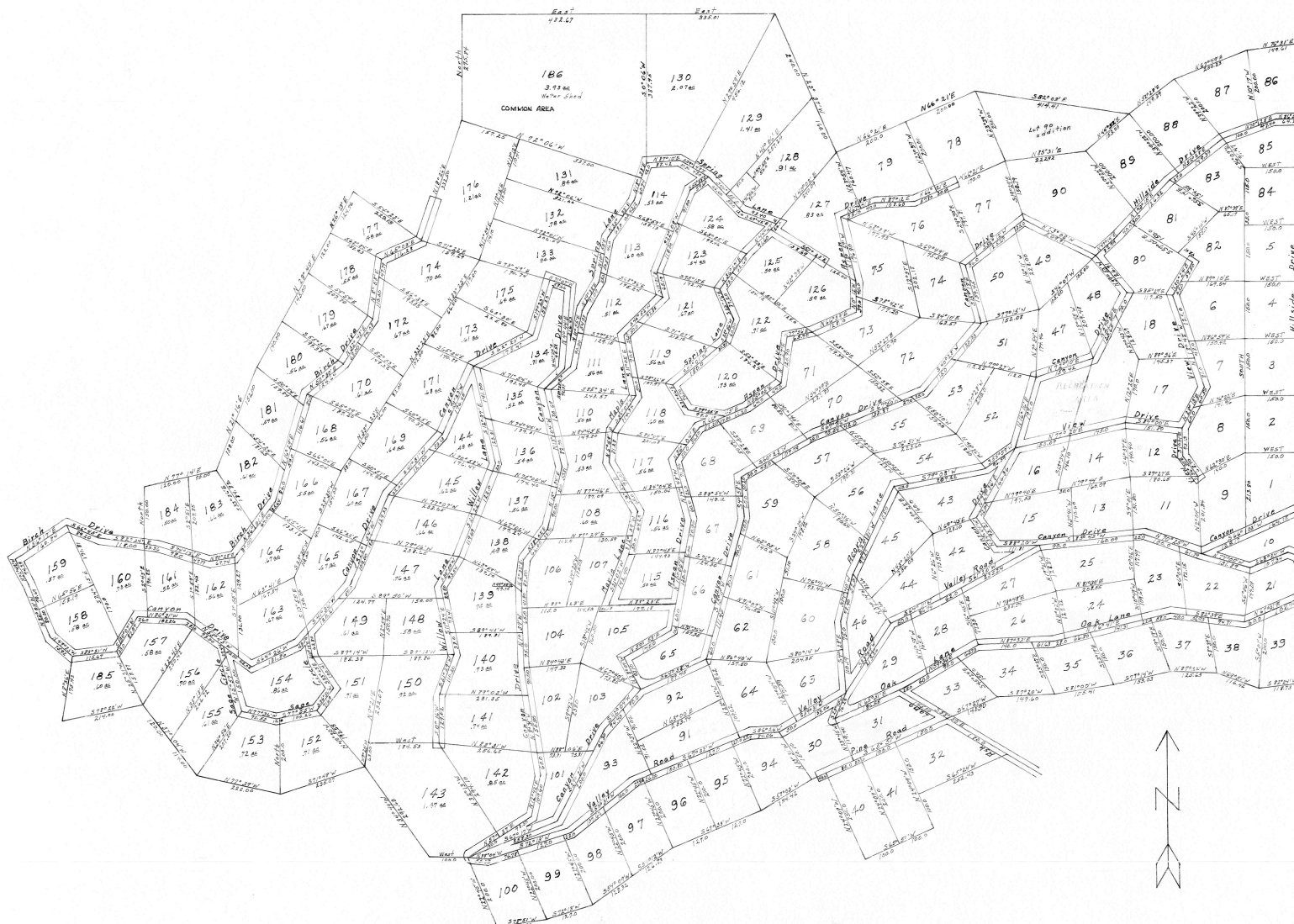




SURVEYOR'S CERTIFICATE
